Re-Staking Fee	\$ 30.00

**Culvert Installation Fees**

24' – 12"	\$ 500.00
24' – 15"	\$ 575.00

\*Additional culvert length in excess of above 24' will be pro-rated on a per foot basis in accordance with the above schedule. Required bands to connect the additional length will be equal to 1 ½ foot of length on the same pro-rated basis. Culverts in excess of 15" will require technical review. An installation estimate will be provided based on actual project costs.

Annual Blanket Permit	\$250.00
Right of Way Permit	\$150.00
Boring Under Roadway*	\$150.00
Open Cut Roadway – Gravel Surface	\$ 300.00

\*Plowed Cable – Other than Fiber Optic \$150.00 up to 500', plus \$0.10 per foot in excess of 500'.  
Plowed Cable – Fiber Optic \$150.00 plus \$0.10 per foot

Aerial Cable \$150.00—Longitudinal Diagonal crossings reviewed on case-by-case basis & must meet minimum height requirement

\*\*Requires Engineers Review. Minimum 2 year/ \$2000 Maintenance Bond for asphalt or concrete surfaced roads.

Multiple Trips (same load)	\$ 50.00 up to 3 days
Super Move (excess of 14' high, 95' long or 16' wide)	\$100.00 per move
Mobile home	\$50.00 up to 3 days
Mobile Home Annual	\$100.00 per power unit
Annual Blanket Permit - Oversize/Overweight	\$ 100.00 per power unit
Annual Permit – Special Transportation	
For Agricultural Commodities	\$100.00
Seasonal Agricultural Transportation – Frost Laws	\$100.00
Single Trip Agricultural Transportation- Frost Laws	\$20.00
Seasonal Milk Transportation – Frost Laws	\$100.00
